**Green River Road Parking Enforcement**

Mark Rosinski from 111 South Green River Road, Colrain and Wendy Goodman from 529 Green River Road, Greenfield attended the meeting to discuss their concerns about the parking and the trash that has been left on Green River Road. Wendy Goodman has spoken to the Greenfield DPW, Mass Fish and Wildlife, Peggy Sloan from the FRCOG, Colrain Police Chief Chris Lannon, Colrain Board of Health and the Colrain Assessor's assistant about the problem and she is here to share the information that she has gathered and is willing to work with the Town to find a resolution to the problem. After a lengthy discussion it was suggested that Mr. Rosiensi and Ms. Goodman would no longer pick up any trash and Mike Friedlander from the Board of Health suggested that the property owners be contacted and advised to stop cleaning up the trash as well and once it becomes a health problem then the Board of Health act on it. Chief Lannon suggested that the Town purchase some no parking signs and ask that property owners post their property. The no parking will be easier to enforce if the property is posted. Kevin Fox, Scott Sullivan and Chief Lannon will get together and recommend where the no parking signs will be most effective. Kevin will also check the Town by-laws to see if there is anything that would prevent the signs from being erected.

**Solarized Colrain Contract Legal Expenses**

The Town of Shelburne is asking that the Town of Colrain pay its share of the legal expenses for the sum of \$229.16.
