Septic Regulations

Overview by Kurt of FRCOG. "These Regulations of the Colrain Board of Health are enacted for the purpose ofprotection of the citizens of the Town of Colrain and also the protection of the environment. As aminimum code, Title 5 is incomplete and ambiguous in certain specifications and silent on other topics. Accordingly, local Board of Health regulations are necessary to assure more complete protection from sewage overflow to the ground surface, which is a source of filth and disease, and also to assure more complete protection from potential pollution of ground water, wells, surface waters, wetland complexes, and certain geologic and water-bearing deposits".

- f. 22 Heath Rd [Update on violations and Order to Correct] one more set of orders will be sent and then this will become a housing case

- **4.** Narcan boxes for Colrain and possible placement Discussion of who will stock Narcan boxes, and what should be included (ie. Fentanyl test strips). We'll need permission from the town to put these up. Ideas for locations include outside fire department, foyer of town hall, catamount country store. Nina will discuss with new town administrator in a few months.
- **5. Community Health Center letter of support** no longer needed, as location (former fire station) not available.
- **6. MAPHCO** Barbara attended meeting. Encourages board to look at RAPT tool, which supports towns with resiliency and emergency planning.
- Discussion about increased communications with other town leaders ie selectboard to be continued
