re: conservation – they've absorbed mold, dirt, 100 years of mess.

There are government grants to survey for conservation

Under present circumstances, no safe way to keep them from further damage/decay

no good way to conserve them in the library "hermetically sealing them will just get the mold more excited"

shouldn't be spending our money on restoration of the busts

Library had been advised to get rid of anything moldy... Conservators report (2020) get rid of superfluous/extra things and mold vectors

Are we a library or a museum?.... Limited resources: need to focus on the scope of a public library

Mold allergies should be a major concern for the staff

Concern for the staff the longer this draws out

If we're concerned about mold, need to look at the entire contents of the basement multiple accounts of people reporting mold response, need to leave the library

Motion made by Mikaela, Betsy (2nd)

Based on the condition of the busts and on the recommendations of multiple conservators and consultants, and the recommendations of the library director, the board votes to immediately remove all the busts from the public area of the library, to store them safely, with the intention of seeking professional advice to help us relocate them to an appropriate venue.

Motion passed, One abstained.
