¹ On July 16, 2022, Lt. Governor Polito, as Acting Governor, signed into law An Act Extending Certain COVID-19 Measures Adopted During the State of Emergency. Chapter 2 of the Acts of 2023 authorized a further extension – until March 31, 2025 – of the remote meeting provisions established by the initial March 12, 2020 Executive Order Suspending Certain Provisions of the Open Meeting Law. 





Along with installing new poles and wire, we will converting the system voltage in this area due to material shortage of transformers. To bring this road up to Eversource current standard 6 Jointly owned mid-span poles are required to shorten span length, increasing reliability. The first pole will be located 120' NE of existing jointly owned pole 24/6M.

120' NE of P24/6M, 175' SE of P24/14, 170' SE of P24/15, 162' SE of P24/16, 155' of P24/17, 156' SE of P24/21. Eversource has obtained permission of 3 additional mid-span poles that will be located on private property, outside the town taking.

Wherefore they pray that after due notice and hearing as provided by law, they be granted joint or identical locations for and permission to construct and maintain a line of poles, wires and cables, together with such sustaining and protecting fixtures as they may find necessary, said poles to be erected substantially in accordance with the plan field herewith and made a part hereof marked—19230428.

Also for permission to lay and maintain underground laterals, cables and wires in the above or intersecting public ways for the purpose of making connections with such poles and buildings as each of said petitioners may desire for distributing purposes.




