#### Jason Ferenc - Colrain Central School Lease - Final Version

Jason informed the Board of the progression of the proposed lease and believes the 10-year lease for the school building is fair. Jason reviewed the new proposed lease that would guarantee that the building would be insured, and the Town would have additional rights being able to deal with the insurance company directly and if the policy is cancelled the Town will be notified. Jason reviewed the insurance provisions that was obtained in this lease. The school will have to put us on as an additional insurer. The biggest condition the school gave the Town was reducing the lease to 10 years. Jason informed the Board that they do not have to take action tonight. The School committee is voting on this tonight and will be forwarding the signed agreement to the Board for their next meeting. Jason is pleased with the progress and the way the lease turned out.

#### Letter from AT&T

Kevin informed the Board that AT&T informed the Town that the lease will be subletting to Tower Co. Tower Co. would like to come to the next meeting to discuss this move. Jason informed the Board that AT&T can assign the lease to another company that is in the lease. Jason said that the lease is very clear that any Company renting space on the tower will pay a fee of 18% of the monthly rent, which is written clearly in the lease. Jason would attend the meeting.

## **Dog Bylaws**

Jack asked Jason how the Town updated the dog regulations to reflect the changes in the current Mass General Laws. There was discussion on how to correct the dog bylaws to reflect the current MGL and how to introduce changes. Mark suggested talking to Shawn Kimberley for suggestions on changes to the dog bylaws. Jason informed the Board that the Dog Bylaws must reflect state law, but the zoning bylaws can enforce stronger regulations.
